COLLECTION DESCRIPTION

The Ithaca Savings Bank was founded in 1868 in a drugstore on State Street. It later became the Citizens' Savings Bank. These records are primarily concerned with property transactions of many Tompkins County residents from the 1890s to the mid-20th century.
