COLLECTION DESCRIPTION

From 1995-1999, two Ithaca organizations worked to make high-speed Internet access available throughout Tompkins County. This collection contains various documents and materials of the two organizations: the Electronic Futures Committee and the Partnership for an Electronic Future. These materials originally belonged to Jean Currie, a member of both organizations and director of the South Central Regional Library Council. Materials consist of meeting minutes, correspondence, research articles, and budgetary items, as well as personal notes and insights by Currie.
