Also papers of a nineteenth century historical society, primarily biographies of Iroquois James Logan (Tahgahjute, son of Shikelamy), chief of the Mingo.
- Folder 2:** Postcards of dioramas of Iroquois life in N.Y. State Museum, Albany; drawing of Joseph Brant; Baker Hall's lecture notes on pre-Iroquois and Iroquois relics; newspaper clippings

- Archeological Society of Central New York:** Copies of their *Bulletin* contain significant amounts of information about local Native American artifacts and villages
 - Lewis Henry Morgan:** Morgan was a lawyer who aided Senecan Ely S. Parker in preventing Ogden Land Company from seizing Senecan land near Buffalo; Morgan's 1851 report made to the Regents of the University, "Implements and Utensils of the Iroquois"; Most of the rest of file is about an European-American secret society, the Grand Order of the Iroquois
 - Native American:** Contains an 1849 treatise about N.Y. State archeological findings
